# Work Group Highlights

**Equity in Community Work Group (EiCWG) & Resilience Fund:** Stop by to learn about EiCWG's recent achievements and collaborations across SC4, ask questions and sign up for TA to get help with your application for Climate Bond Funding (from CQ and CRC). Likewise, offer your input on potential criteria for grant-making for the SCC Climate Resilience Fund across jurisdictions including CBOs, public agencies and private sector perspectives.

**Flooding and Sea Level Rise (FSLR) Work Group:** Learn about efforts to advance cross-jurisdictional coordination of multi-benefit urban greening efforts, especially for priority communities like East San Jose.

**Heat and Air Quality Resilience (HAQR) Work Group:** Share input on extreme heat strategies to prepare for upcoming funding opportunities and help shape topics for the group's 2026 quarterly meetings.

**Santa Clara Valley Urban Forestry Alliance (SCVUFA):** Learn about the regionwide Urban Forest Master Plan and how it'll serve as a road map to support and foster regional urban forestry management.

**Climate Pollution Reduction Grant (CPRG) Work Group:** Soliciting feedback on focus areas and coordination for implementation of the Comprehensive Climate Action Plan post the December 1, 2025 submission to EPA.

**Resilience Hubs Work Group:** Learn more about the new work group and help shape a coordinated, community-driven approach to preparing for climate impacts and ensuring that every neighborhood has the resources to thrive before, during, and after disasters.

• Finalize measures and actions to be included in the CCAP	End of May 2025
• Technical analyses	May– July 2025
• Initial draft of CCAP for internal review by SBC and SCC counties	Mid-June 2025
• CCAP submittal to EPA	July 11, 2025
• CPRG WG and public comment and feedback on measures and actions	August/Early September 2025
• Future of CPRG Work Group meetings	November 2025
• CCAP submittal to EPA	December 1, 2025

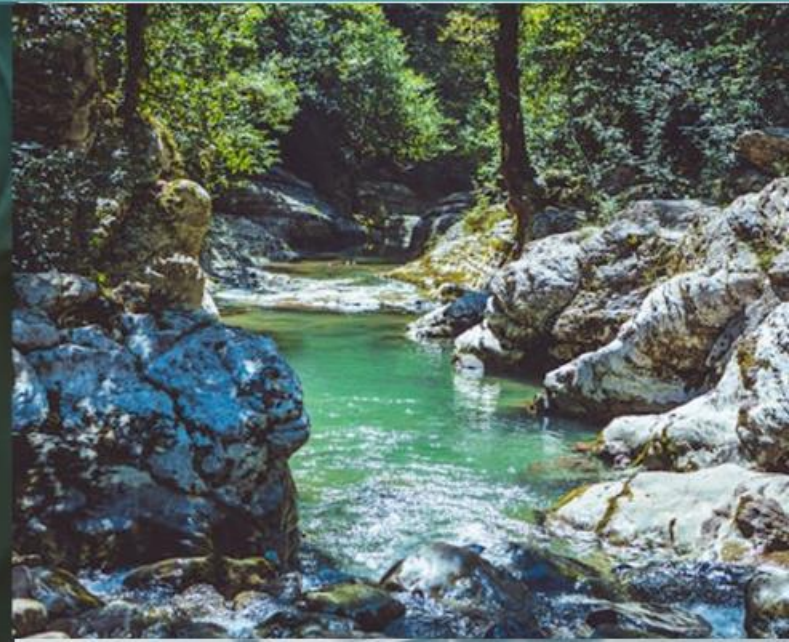
- Submission to EPA on December 1, 2025
